

MUNICIPAL TAXES

All Municipal Taxes should be distributed by Mid-February 2017. There will be a 10% discount for those residents who pay by 31 March 2017. As well, any resident in receipt of a Guaranteed Income Supplement (GIS) may make application for a 20% discount in the municipal taxes. Please contact the Town Office for more details.

- Taxes are due by 15 April 2017
- Payment by 31 March will receive 10% discount
- Residents in receipt of GIS may apply for 20% discount (*not to be combined with any other discount*)
- Interest will be 2% on taxes not received by due date.
